

## **Schools/Districts Registration January 11, 2024 CreativeCon Terms & Conditions**

I understand that I am the authorized representative/contact with SparkPath for my school/district. I am responsible for sharing all CreativeCon event information and materials with those involved at my school/district including administration, teachers, chaperones, parents/guardians, and students.

I understand that the registration fee per student is based on BrightWorks membership status and the registration deadlines below:

**BrightWorks Member:** Early Bird \$41/student (\$43 after November 3)

**Non-Member:** Early Bird \$55/student (\$57 after November 3)

### **I understand that by:**

- **November 20, 2023** - I need to submit my signed contract to SparkPath. This date is the deadline to reduce registration numbers without incurring a 30% charge per each student registration cancelled.

*SparkPath is committed to offering high-quality, affordable events. This charge helps offset costs incurred due to cancellations.*

- **December 1, 2023** - payment is due to SparkPath.

- **December 5, 2023** - I must communicate any decrease in student numbers in order to receive a partial refund. No refunds will be issued if requested after this date.

### **I understand that:**

- I can contact Madi Grove to ask about adding students to my registration. Space allowing, SparkPath will try to accommodate the request.

- this event will take place unless the University of Minnesota is closed due to unforeseen and/or unusual circumstances.

- session tickets are randomly generated for the attendees and session preferences are not guaranteed for individuals or school groups.

- my school/district must provide one adult chaperone for every fifteen students attending this event.

- all transportation and associated costs are my school/district's responsibility.

- parents/guardians may register their child separately from their school group regardless of the school's selection process. In such cases, parents/guardians are responsible for payment, event materials, transportation, and chaperoning their individual student at the event.

### **Important Dates:**

- **December 1, 2023** - I need to return a copy of my registration confirmation email with a check mailed to SparkPath or coordinate with Madi Grove to pay with a credit card through PayPal. Event materials and session tickets will be mailed after payment has been received by SparkPath.
- **December 15, 2023** - Refunds will not be issued if requested after this date.

### **I understand that:**

- I am the authorized contact with SparkPath for my student(s) and they are not attending CreativeCon with their school or district.
- I, or another responsible adult I have designated (18 years or older), must remain on the University of Minnesota campus during this event to act as a chaperone while my student(s) attend(s) the event.

The chaperone is not required to escort my student(s) at all times. However, the chaperone must remain with my student(s) during the opening, lunch, meet them at the end of the day, and be available on-site in case of emergency.
